2. Grant of License. 3. No Sale. 5. Fees. In consideration for this License, Licensee will pay Licensor required fees for Software.

6. **Proprietary Rights.**

(a) <u>Retained Rights</u>. This is a license, not a sale. All rights not expressly granted are reserved by Licensor and its software suppliers who retain all rights, title and interest in and to the Software and Documentation. Licensee acknowledges that this EULA does not grant Licensee either

(1) title to the Software or Documentation licensed hereunder or (2) any intellectual property rights in the Software or Documentation, any derivatives or improvements thereof or in Licensor's trademarks or service marks.

(b) <u>Legally Protected</u>. All such intellectual property rights are protected at local, national and international levels by various laws and treaties, including, but not limited to, those related to trade secrets, copyrights, trademarks, service marks and patents.

(c) <u>Trade Secret</u>. The Software and Documentation constitute valuable assets and trade secrets of Licensor and its software suppliers, embodying substantial creative efforts and confidential information, ideas, and expressions. No license is granted Licensee to the human readable code (source code) of the Software. 14. Term and Termination. The licenses and rights provided to you by this EULA are effective as of the earlier date of your first use of the Software or the date you purchased the Software from Licensor and continues until terminated. Your rights to the Software terminate automatically without notice from Licensor if you fail to comply with this EULA. Licensee may terminate this License upon written notice of termination to Licensor.

15. Internet Updates. The Software may connect to Licensor or its service provider over the Internet from time to time to obtain updates or additional components for installation. You may not receive a separate notice when the Software makes this connection, or upon installation of such updates or components. 16. Governing Law/Jurisdiction/Dispute Resolution. All matters pertaining to this EULA and its subject matter (including its interpretation, application, validity, performance and breach) must be brought within, and shall be governed by, construed and enforced in accordance with the laws of, the State of California (without giving effect to its conflicts of law principles), unless Licensee is a governmental entity required by law to enter into agreements governed by the law of Licensee's state or Licensee is subject to a law that requires the application of an alternate law. Unless otherwise prohibited by applicable law, the parties herein agree to submit to the personal jurisdiction and venue of a court of subject matter jurisdiction located in San Francisco, California. In the event that litigation results from or arises out of this EULA or the performance thereof, the Licensee agrees to reimburse the Licensor its reasonable attorneys' fees and court costs should it be the prevailing party, in addition to any other relief to which the Licensor may be entitled. The parties agree that this EULA is not a contract for the sale of goods; therefore, this EULA shall not be governed by any codification of Article 2 or 2A of the Uniform Commercial Code, or any codification of the Uniform Computer Information Technology Act (UCITA), or any references to the United National Convention on Contracts for the International Sale of Goods.

17. Injunctive Relief. Licensee agrees that, in addition to any other rights or remedies which Licensor may have at law or in equity, Licensor shall be entitled to injunctive relief in any court of competent jurisdiction for any breach or threatened breach of the terms and conditions of this EULA. Licensee agrees that any breach of this EULA constitutes irreparable harm and that monetary damages alone do not provide Licensor adequate relief.

18. No Agency. Nothing in this EULA is intended to construe the existence of a partnership, joint venture, or agency relationship between Licensee, its contractors, its suppliers, its distributors and affiliates and Licensor.

19. Not Fault Tolerant. The Software is not faulttolerant and is not designed, manufactured or intended for use or resale with online control equipment in hazardous environments requiring fail-safe performance, such as in the operation of nuclear facilities, aircraft navigation or communication systems, air traffic control, direct life support machines or weapon systems in which the failure of the Software could lead directly to death, personal injury or severe physical or environmental damage.

20. Miscellaneous. Licensor shall not be responsible or liable for any failure in performance or loss or damage due to any cause beyond its control. This EULA shall be given equal consideration in its construction and interpretation without regard to which party drafted it.
